# Friendsville Mayor & Town Council Minutes September 9, 2024

**Call to Order:** Council President Humberson, convened the general meeting of the Mayor and Town Council on September 9, 2024, at 6:00 p.m.

**Opening Ceremonies:** All attending the meeting recited the Lord's Prayer and the Pledge of Allegiance to the Flag of the United States of America.

#### Approval of the Agenda – September 9, 2024

**Motion #1**: (Council member MacLane/Council member Kelley) Approval to accept the September 9, 2024, agenda with no additions or corrections. 6 in favor/0 opposed/0 abstention. Motion carries.

#### Approval of the General Meeting Minutes – August 19, 2024

**Motion #2:** (Council member Kelley/Council member Artice) Approval to accept the general meeting minutes for August 19, 2024, with no corrections or additions.

5 in favor/0 opposed/1 abstention. Motion carries.

#### To The Floor:

#### Friendsville Volunteer Fire & Rescue Department

Terry Spear asked about the remaining grant funds, which could potentially be used to purchase equipment for the concession stand and ADA restroom. Currently, no change orders have been submitted by the contractor. The remaining balance is \$4,920.10. The fire department will cover the cost of any equipment that exceeds this amount. It is crucial for FEP that the equipment is installed correctly, with nozzles positioned precisely above it. Terry will send an email with a list and pricing details for the equipment. Mayor Schlosnagle will check with Siera Wigfield regarding the purchase of the equipment.

Terry acquired roughly 30 acres of land adjacent to his existing property, which includes a parcel owned by the Town of Friendsville (Map: 0300 Grid: 0023 Parcel 0080, 0.35 acres). He has inquired about the possibility of purchasing this town-owned parcel or, alternatively, requested that the town install a fence around it, as it contains a spring/well.

#### Garrett County Sheriff's Office

Corporal Lewis, Garrett County Sheriff's Department shared the Town of Friendsville's incident report for the month of August. There was a total of 9 occurrences during the month, 4 community patrols, 1 K9 traffic scan, 1 possible methamphetamine and 3 special assignments. No questions from the floor or town council members. Mayor Schlosnagle reiterated the importance of continuing to patrol the Community Park and that the seven of the eight towns including Town of Friendsville will have Trick or Treat on October 31, 2024, 5:30 p.m. – 7:00 p.m. request patrol that evening.

#### **Unfinished Business**

#### Pickleball Court Updates

Mayor Schlosnagle reported that Todd Diehl moved the posts further out but did not have the paperwork at the time of the original installation. As a result, he will not charge for the adjustments. Additionally, the pickleball court has been repainted.

#### **Business After Hours Event Update**

The event is Thursday, September 12, 2024, from 5:00 p.m. – 7:00 p.m.; reminded everyone that if you are planning to attend registration is required. Mayor Schlosnagle reminded that the council should plan to attend.

#### Halian Landscapes Proposal

We received notification from Charity with Halian Landscapes that they plan to come the week of September 16, 2024, to plant the "sugar maple" tree at 255 Maple Street. She will call closer to the time to confirm the exact date and time of their arrival.

#### Alleyway – Maple to Walnut

Mayor Schlosnagle will reach out to Paul Harvey to get a cement barrier for the alleyway between Maple Street and Walnut Street near Friendsville Pharmacy. This barrier will need to be painted or have reflective tape added. We have opted for this solution instead of buying bollards from Uline or using the cement-filled barriers that we already own. If the county does not have a barrier available, we will check with the State Highway Administration for options. The signage has been received and is ready for installation.

#### Annual Holiday Decorating Contest/Christmas Dinner – December 16, 2024

The Mayor & Town Council concurred to keep guidelines and prizes for the annual holiday decorating contest the same as 2023 at the August 19<sup>th</sup> meeting, Wanda asks for a motion from the floor.

**Motion #3:** (Council member Sines/Council member MacLane) Approval to accept the 2024 Annual Holiday Decorating Contest guidelines for December 16, 2024, and prizes to be distributed as follows:

- First Place in the Residential Category: \$100.00
- Second Place in the Residential Category: \$75.00
- Third Place in the Residential Category: \$50.00
- First Place in the Business Category: \$100.00
- Second Place in the Business Category: \$50.00

noting that a residence or business is not eligible to win in two consecutive years, ensuring a fair chance for all participants.

6 in favor/0 opposed/0 abstention. Motion carries.

The Christmas/Holiday gathering is set for Monday, December 16, 2024. Council member Kelley confirmed that the Fire Department is available, and the Special Event Committee will be able to cater the dinner.

#### MML Fall Conference

The City of Cambridge will host the 2024 Excellence in Leadership Fall Conference from November 6-8, 2024, at the Hyatt Regency Chesapeake. Council members MacLane and Artice, along with Mayor Schlosnagle, will attend, traveling down on November 5 and returning on November 8. The early bird registration fee for the conference is \$450.00 per person, and with approximately \$145 per room per person, the total cost will be around \$1,785.00, plus any additional meals and fuel expenses.

#### **Proposals Friend Family Museum**

Mayor Schlosnagle reported that Cornerstone Construction, LLC, Rounds Construction, Harner Construction, and Crellin Handyman Services LLC have assessed the necessary work for the Community Legacy grant regarding the Friend Family Museum – Library exterior improvements project to submit proposals. We have received one proposal from Crellin Handyman Services LLC for \$15,500.00 (Appendix A).

**Motion #4:** (Council member Hook/Council member Sines) Approval to accept the proposal from Crellin Handyman Services LLC.

5 in favor/1 opposed/0 abstention. Motion carries.

#### Library Variance Application

Mayor Schlosnagle shared that the planning commission members met on Thursday, August 29, 2024, and gave their recommendation, and we will proceed with a public hearing regarding the zoning ordinance. The Friendsville Board of Zoning Appeals will conduct a public hearing on Tuesday, October 1, 2024, starting at 6:00 p.m. in the Friendsville Town Hall in the council chambers. The Board will review the following docketed case: VR-2024-1: An application submitted by the Ruth Enlow Library of Garrett/Thomas Vose for variance to allow 21 fewer parking spaces than specified in the town ordinance 600D. Mayor would like to have the council members also plan to attend the meeting.
